Thank you for your continued care of this gentleman, who was recently admitted to Singapore General Hospital for bilateral lower limb cellulitis.

During this admission, the physiotherapist and occupational therapist reviewed the patient, and ascertained that the patient requires contact assistance for daily activities. He showed poor static sitting when mobilizing to edge of the bed, and was unable to consistently sit upright unsupported.

He will be needing a caregiver for contact assistance going forward.
